The Rules

- The name is the Provincial 500 Club and it is run by the Royal Arch Province of Surrey
- 2. The address of the Club shall be the Provincial Office.
- The objective of the Club is to raise money for the Surrey for Surrey Fund.
- 4. The Club shall be managed by a committee of three Companions nominated by the ME Grand Superintendent, one of whom shall act as Hon. Chairman, one as Hon. Treasurer and one as Hon. Secretary.
- Membership shall be limited to Companions, Brethren and their immediate families and Chapters and Lodges of the Province of Surrey
- Membership shall initially be limited to 500. The committee may in its absolute discretion decide to increase this number from time to time
- Subject to a fully paid subscription, all members shall be entitled to take part in prize draws, one held at the dinner at the Annual Convocation or the AGM of the Craft and one at or about the second week of December (Christmas Draw).
- The prizes are those described in this brochure but may be of a pro rata value (higher or lower) dependant on the numbers sold.
